- Appointment as Examiner in any given year does not confer the right to an appointment in subsequent years.
- If you fail to comply fully with our Instructions or if you act in a way that jeopardises the security or integrity of the examinations or the performance of the candidates, you may be dismissed and may be refused any future appointment. If you are dismissed, you will have no claim whatsoever against us for remuneration or expenses.
- Travelling expenses and subsistence allowances will be paid in accordance with Department of Finance regulations.
- All payments to you will be made through Paypath, an electronic money transfer system.
